13221 *Anuncio del ADIF-Alta Velocidad por el que se somete a información pública, a efectos de expropiaciones, el Proyecto de Construcción de Plataforma de Integración Urbana y Acondicionamiento de la Red Ferroviaria de Ourense. Tramo: Túnel de Montealegre-Estación de Ourense.*
